The O'Hare Noise Compatibility Commission provides a public forum to address community noise issues related to aircraft operations at O'Hare International Airport. - If you wish to address the ONCC, you must be present and complete the comment card outlining the question or area you wish to address. Before making comments, identify yourself to the Chair and Commission members by stating your name and address.
- Comments beyond ONCC's purview will not be allowed to be verbally given, but a written set of comments may be submitted for consideration to be added to the meeting minutes. Meeting attendees are reminded that ONCC has taken a neutral position on the O'Hare Modernization Program as reflected in the FAA's Record of Decision
